4. **PRESENTATION AND REVIEW OF NEVADA REVISED STATUTES (NRS) 480.530-545 ESTABLISHING THE NEVADA THREAT ANALYSIS CENTER AND THE NTAC ADVISORY COMMITTEE** – (Discussion Only) – Chair, Chief Ryan Miller will provide an overview of the role and responsibilities of the Committee and discuss the statutory requirements for the NTAC and the Committee stated in Nevada Revised Statutes (NRS) 480.540-545.

Robert Haigney, NTAC Director and Dr. Selby Marks, NTAC Deputy-Director. Lt. Haigney and NTAC staff will provide the Committee members with an overview of the NTAC operations and program areas.
6. **NTAC STAFF INTRODUCTION** – (Discussion Only) – Lt. Robert Haigney, NTAC Director. Introduction of NTAC staff to the committee members and description of each of their areas of expertise.
7. **PUBLIC COMMENT** – (Discussion Only) – No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action may be taken. Public comments may be limited to 3 minutes per person at the discretion of the Chair. Comments will not be restricted based on viewpoint.
